Academic Island Participation Agreement

Please read the following information, print, sign, and submit with the application package.

Academic Island welcomes international students as guests to its partner schools. This agreement outlines the terms that international students must abide by while participating in an Academic Island program, living in Newfoundland, Canada, and living in a homestay.

Part A: General Policies The student and his/her parents or legal guardians hereby agree that:

1. The student must obey the laws of Canada, the Province of Newfoundland and Labrador, follow the policies/procedures of the partner school and school board, and the terms outlined in this Participation Agreement.

2. The student must follow all school and board regulations regarding attendance, course responsibilities and behaviour.

3. The student must provide complete and accurate information. False information in the student's application may result in immediate dismissal from the Academic Island International Education Program without refund of tuition fees.

4. The student will use the homestay provided by Academic Island.

6. The student must attend all assigned classes unless unable by reason of illness or injury, in which case the student must provide a note for any absences. A Doctor's note may be required.

7. The student must refrain from purchasing, possessing or consuming any illegal substance including, tobacco, cannabis, alcoholic beverages or any other controlled narcotic without a prescription from a physician.

8. The student must refrain from driving a motorized vehicle. An exception will be made to participate in an accredited driver's training program. Academic Island will hold the student's driver's license until the student returns to their home country.

9. The student's information my be communicated by Academic Island to a student's parents and/or other appropriate officials, regardless of the student's age.

10. The student and his or her parent(s) agree to respect and abide by the host family's house rules.

11. The student is responsible for personal expenses, including international telephone calls, and personal hygiene items, etc.

12. The student's participation in an Academic Island international program means that program fees cover monthly charges for room, board, medical insurance and tuition.

13. The student requires the permission of the host family/custodian to travel within the province of Newfoundland and Labrador. A student can travel with the host family, a school group, or other approved individuals/families.

14. The student requires the permission of Academic Island to travel outside Newfoundland and Labrador.

15. The student's family may visit from their home country, but not until six weeks after the student's arrival in Newfoundland. If the student's family visits, they must make arrangements for their own lodging and not assume they can stay with the host family.

I certify that I understand the terms of enrollment in an Academic Island international education program is articulated through this Participation Agreement and understand that Academic Island reserves the right to terminate a student's participation in its program for violation of program rules and /or when a student's mental and/or physical health, as determined solely by Academic Island, are in jeopardy. If expelled from Academic Island, there is NO refund and the student will be sent back to their home country at their own expense.
